We ask that you review the following information about the tour and comply with them so that your tour runs safely and efficiently within the confines of the construction process.

Please read and sign the attached waiver. Bring the waiver with you on the day of the tour. All waivers must be handed to the tour leader before the tour starts.

**Caution:**

- Must be at least 16 years of age and those under 18 must be accompanied by an adult.
- Areas toured maybe dim, dusty, confined, narrow, warm or cold.
- No personal items are to be brought on the tour, including but not limited to purses, cameras, cell phones and flashlights.
- **No photography is permitted for safety reasons.**
- This is construction site. Do not touch or lean on anything.
- Group must stay together at all times.
- Tour is not handicap accessible.

**Attire:**

- Long pants and sturdy shoes must be worn.
- Footwear needs to be sturdy, NO open-toe shoes, flip-flops, high heels or sandals permitted.
- Hard hats, eye protection and high visibility vests will be provided and must be worn at all times

Be sure to arrive 15 minutes before your tour starts to allow time for check-in and to ensure a prompt start time.
